Re: Intercessional work on the development of audit points

I am writing with respect to CMM 2018-07 on the Compliance Monitoring Scheme and paragraph 425 of the WCPFC15 Summary Record, which reads as follows: "425. The Commission noted that the measure includes an ambitious workplan for 2019 and that FAC had allocated some budgetary resources to support this work. The Commission welcomed the expressions of interest from some Members to work with other Members during the intercessional period in 2019, to develop draft audit points for the assessment of obligations through the Compliance Monitoring Scheme."

At the recent 110th session of the Forum Fisheries Committee, FFA members reaffirmed WCPFC15's discussions that development of audit points under the Commission's Compliance Monitoring Scheme is important work that needs to be progressed in 2019. FFA members further supported the approach endorsed by WCPFC15, for interested members to take up the work. As the current Chair of the FFC and on behalf of FFA members, I am pleased to offer to lead the intercessional work on the development of audit points and the corresponding checklist of audit points to be used by proponents of new measures, as outlined in paragraph 46(iii) of CMM 2018-07.

FFA members understand that there is no specific funding allocated to this work and that communications will be conducted electronically with the potential for in-person discussions at TCC15.

If there are no objections, I would like to invite other interested CCMs to please nominate a point of contact who will participate in the intersessional discussions to develop CMS audit points and to submit their name and email contact to me at <u>eugene.pangelinan@norma.fm</u> with a copy to NORMA Deputy Director Matthew Chigiyal <u>mathew.chigiyal@norma.fm</u>, no later than May 31, 2019. I plan to circulate a proposed approach for developing audit points to nominated CCM contacts in early June 2019.
