Dear Mr Aguilar,

The Conservation and Management Measure on Cooperating Non-Members (CMM 2009-11) requires the Executive Director to forward a copy of the relevant TCC recommendations and advice to non-members who had submitted an application for Cooperating Non-Member (CNM) status following the TCC11.

The paragraphs below record the relevant recommendations and advice of TCC on the CNM applications reviewed at TCC11.

***Cooperating Non-Member Requests***

TCC11 has reviewed your countries CNM application for 2016 and the application has been forwarded to WCPFC12 for consideration.

TCC11 notes with appreciation the attendance and participation of Ecuador, El Salvador, Panama and Vietnam at this year's meeting and encourages other CNM applicants to attend TCC meetings in the future.

TCC11 notes that all CNM applicants other than Mexico made a commitment to accept high seas boarding. TCC11 notes that all CNM applicants other than Mexico and Vietnam made a financial contribution and notes Vietnam's statement that payment was made over the course of TCC.

TCC11 notes the position of some CCMs at WCPFC11 regarding provision on non-payment and notes the WCPFC11 summary record which recorded that WCPFC11 agreed to approve the application for renewal of CNM status in 2015 from Mexico on the understanding that the Secretariat will write a letter to Mexico advising that Mexico's non-payment of any financial contribution generated extensive discussion at WCPFC11. Some CCMs noted their strong concern at the unfairness for SIDS CCMs and other CNMs due to this non-payment and those CCMs did not consider the lack of presence of any Mexico vessels to justify non-payment. Those CCMs also noted that if this concern

is not addressed before Mexico's next application for CNM status any such application would not be supported by those CCMs.

TCC11 recommends that Mexico consider the prospect of a voluntary payment in advance of WCPFC12 given this statement in the WCPFC11 record, and its position regarding its national legislation.

TCC11 noted the following gap or issue in the application for Cooperating Non-Member status:

"Mexico— TCC11 notes that Mexico has not provided a commitment to make a financial contribution. TCC11 further notes that Mexico has not made an explicit commitment to accept High Seas Boarding and Inspections."

Furthermore, TCC11 has recommended to the Commission that it take into consideration the Compliance Status of all CNM applicants in making its decision at WCPFC12 on the CNM applications and participatory rights.

### AGENDA ITEM 3 - CNM REQUESTS

110. In introducing this agenda item, the Compliance Manager noted that all seven CNM requests for 2016 were submitted using the electronic form endorsed last year; additionally, all were received on time. The meeting was directed to WCPFC-TCC11-2015-08\_rev3 for detail on the seven CNM requests. The paper provides information around dates of receipt of information and also some notes on the financial contributions received to date.
111. A small working group chaired by New Zealand (Shannon Tau) was requested to develop a first draft of recommendations and technical advice for TCC11's consideration. The small working group was asked to take note of para. 154 of the WCPFC11 report which "accepted the recommendation from the CNM SWG that a more directive and particularised letter from the Secretariat be provided to a CNM applicant after TCC where an incomplete application had been identified."
112. The Chair asked that representatives from CNM applicants participate in the working group to provide further information and clarified that TCC's role was to assess and provide recommendations and technical advice on the CNM applications.
113. Shannon Tau, the small working group Chair directed TCC to working paper WCPFC-TCC11-2015-29 which outlined some of the discussions that had taken place in the small group and draft TCC11 recommendations to WCPFC12.
114. During the SWG, some CCMs noted their position that where CMM 2009-11 requires an explicit commitment to the Commission such as financial contributions that these commitments should be actually met. One CCM noted the FFA position that a proposal to amend the measure to make payment compulsory would be made at WCPFC12. A view was expressed that payment could be linked to the absence or presence of fishing activities but it was observed that the WCPFC11 meeting record stated that some CCMs considered that lack of fishing presence did not justify non-payment. It was observed that if Mexico were a full member this could allow it to make a financial contribution.
115. The conditional status, and subsequent non-granting of CNM status for Senegal was noted. Vietnam requested that a greater breakdown of the financial contributions be provided by the Secretariat to assist in its internal financial processes and if possible, a forecast of future assessments when the Secretariat write to invite CNM applications following WCPFC12. The issue of general capacity management was raised as an issue to be discussed further at WCPFC12 and all CNM applicants participating in the SWG expressed willingness to cooperate in capacity management in the Convention area
116. As this item came to the floor late on the final day of the meeting, in the interests of time, the Vice-Chair asked TCC if it wanted to accept the recommendations as a report. The meeting agreed to accept the recommendations as drafted by the SWG. The Vice-Chair thanked New Zealand and the CNM small working group for their work.
117. TCC11 provides the following decisions and recommendations to WCPFC12:
- a. TCC11 has reviewed the following CNM applications and is forwarding them to WCPFC12 for consideration: Ecuador, El Salvador, Liberia, Mexico, Panama, Thailand, and Vietnam.

b.	TCC11 again thanks the Secretariat for the development of the CNM application template which assisted the process greatly and thanks CNM applicants for using the template and submitting their applications in accordance with the prescribed timeframes.				
c.	TCC11 notes with appreciation the attendance and participation of Ecuador, El Salvador, Panama, and Vietnam at this year's meeting and encourages other CNM applicants to attend TCC meetings in the future.				
d.	TCC11 notes the CNM working group process occurred in parallel with the compliance monitoring scheme process and recommends that following TCC11, in consultation with SPC, the Secretariat write a particularised letter to CNMs outlining any identified deficiencies in data provision and requests that CNM applicants provide any information outlined in these letters, and as requested during the CMS process, 30 days in advance of WCPFC12 and that these letters, and any responses be assessed by WCPFC12.				
e.	TCC11 recommends that WCPFC12 take into consideration the Compliance Status of all CNM applicants in making its decision on the CNM applications and participatory rights.				
f.	TCC11 notes that all CNM applicants other than Mexico made a commitment to accept high seas boarding.				
g.	TCC11 notes that all CNM applicants other than Mexico and <del>Thailand</del> -Vietnam made a financial contribution and notes Vietnam's statement that payment was made over the course of TCC.				
h.	TCC11 notes the position of some CCMs at WCPFC11 regarding provision on non-payment and notes the WCPFC11 summary record which recorded that WCPFC11 agreed to approve the application for renewal of CNM status in 2015 from Mexico on the understanding that the Secretariat will write a letter to Mexico advising that Mexico's non-payment of any financial contribution generated extensive discussion at WCPFC11. Some CCMs noted their strong concern at the unfairness for SIDS CCMs and other CNMs due to this non-payment and those CCMs did not consider the lack of presence of any Mexico vessels to justify non-payment. Those CCMs also noted that if this concern is not addressed before Mexico's next application for CNM status any such application would not be supported by those CCMs.				
i.	TCC11 recommends that Mexico consider the prospect of a voluntary payment in advance of WCPFC12 given this statement in the WCPFC11 record, and its position regarding its national legislation.				
j.	TCC11 notes that during the SWG four CNM applicants (Ecuador, El Salvador, Panama and Vietnam) have expressed or reiterated interest in becoming full members and that WCPFC12 consider whether to invite them to become members.				
k.	TCC11 notes the following gaps or issues in the applications for individual applicants and encourages applicants to rectify them if possible by WCPFC12: <table> <tr> <td>i.</td><td>Mexico – TCC11 notes that Mexico has not provided a commitment to make a financial contribution. - iv. Vietnam – TCC11 noted that Vietnam’s financial contribution had not yet been received during TCC11 but that Vietnam made a statement that payment was pending.

- 118. Japan asked to make one comment regarding the CNM applicant Vietnam for the record. This ~~ECM-CCM~~ noted that Japan and the WCPFC had been promised by Vietnam that information would be provided relating to the construction of large-scale tuna vessels in Vietnam. Japan stated that during TCC it had received positive indications from Vietnam. Japan welcomed Vietnam’s positive attitude to addressing capacity management in the WCPO by providing information. Japan sought Vietnam’s cooperation to control the construction of large-scale tuna fishing vessels, and report to the Commission regarding capacity management in the WCPFC.

The Vice-Chair referred the meeting to the last sentence of the report of the SWG (WCPFC-TCC11-2015-29) which says “The issue of general capacity management was raised as an issue to be discussed further at WCPFC12 and all CNM applicants participating in the SWG expressed willingness to cooperate in capacity management in the Convention area.”

**2015 PROVISIONAL COMPLIANCE MONITORING REPORT  
(COVERING 2014 ACTIVITIES)  
Executive Summary**

**I. INTRODUCTION**

1. TCC11 undertook its fifth annual review of compliance by CCMs against a priority list of Commission obligations agreed to at WCPFC11. (Att U to WCPFC11 Summary Report)
2. TCC11 has provisionally determined that the following CCMs are considered to be “Compliant” under the provisions of CMM 2014-07: Cook Islands, Mexico, New Caledonia, Nauru and Vietnam.
3. TCC11 has provisionally determined that the following CCMs are considered to be “Non-Compliant” under the provisions of CMM 2014-07: Australia, Canada, China, Ecuador, European Union, Fiji, Federated States of Micronesia, France, Indonesia, Japan, Kiribati, Republic of Korea, Marshall Islands, Niue, New Zealand, Panama, French Polynesia, Papua New Guinea, Philippines, Palau, Solomon Islands, El Salvador, Thailand, Tokelau, Tonga, Tuvalu, Chinese Taipei, United States of America, Vanuatu, Wallis and Futuna, and Samoa.

**II. DEVELOPMENT OF THE PROVISIONAL COMPLIANCE MONITORING REPORT BY TCC11**

4. TCC11 reviewed the draft Compliance Monitoring Report (draft CMR) for 36 CCMs in a closed working group session. The draft CMR is classified as non-public domain data as a number of CCMs were not able to agree to release their non-public domain data, therefore the decision was made to close the session.
5. TCC11 agreed to conduct the compliance review process in accordance with the agreed principles articulated in WCPFC-TCC11-2015-23 rev 1.
6. The tier scoring system adopted by WCPFC11 assisted in evaluating the compliance of CCMs for the provision of scientific data and TCC11 concluded that it was very useful and informative tool.
7. TCC11 notes that the Provisional CMR provides its provisional compliance assessment and it is submitting this report to the Commission for its consideration and final assessment.

**III. ISSUES ARISING DURING THE COMPLIANCE REVIEW PROCESS**

*CMM 2007-01, Para 14(vii); CMM 2013-01, para 14; and CMM 2013-01, Para 16*

8. TCC11 encountered difficulty in assessing the obligations in CMM 2007-01, Para 14(vii); CMM 2013-01, para 14; and CMM 2013-01, Para 16. A number of significant issues were raised by both flag states and coastal states.
9. TCC11 reached a compromise for progressing the issue during this year’s assessment; however, many CCMs remained uncomfortable with the agreed way forward. TCC11 note that this reflects a change to the way these obligations have previously been assessed.
10. TCC11 agreed that CCMs would be assessed as Compliant against these obligations if they were

able to provide details indicating that a good faith effort had been made to investigate the alleged violations. However, many CCMs noted that most of the reports of investigations fell far short of what would be considered a full investigation, and would be considering any relevant CCMs actions between TCC11 and WCPFC12 when assessing the final compliance status.

11. TCC11 agreed that the provisional CMR would clearly note the concerns raised with the agreed approach. The following issues were noted:

- a. CCMs take allegations of violations involving observer harassment or interference very seriously;
- b. CCMs consider the annual FAD closure to be a central part of the Tropical Tunas measure;
- c. The revised CMS CMM must include a mechanism that requires CCMs to report back annually on the progress of these investigations until they are resolved;
- d. The Commission must prioritize finding a resolution to facilitate the process for flag states to obtain observer reports relating to alleged violations in a timely manner;
- e. Any solution must include the commitment of both flag states and coastal states that provide observers to collaborate to improve this process;
- f. If the allegations of a violation come from an observer report, any investigation into those violations must include, at a minimum, review of that report;
- g. CCMs noted that a full investigation is the first step and what is most critical is that CCMs address any violations that are found; and
- h. Coastal states shall receive notification of alleged violations occurring in their waters.

12. TCC11 agreed that the agreed process this year was only accepted on the basis that this does not set a precedent for how these obligations will be assessed in the future.

13. TCC11 identified three recommendations to assist in improving this issue in the future.

**14. TCC11 recommends that WCPFC12 prioritize finding a resolution to facilitate the process for flag states to obtain observer reports relating to alleged infringements in a timely manner, noting that any solution must include the commitment of both flag states and coastal states as well as observer providers to collaborate to improve this process. It is the responsibility of all CCMs to work together on this issue as a priority.**

**15. As an initial response to the recommendation in paragraph 13, TCC11 recommends that WCPFC12 adopt IWG-ROP4's recommendations in paragraphs 28 – 31 of the IWG-ROP4 Summary Report to establish a "pre-notification process from observer providers to flag CCMs of possible alleged infringements by their vessels."**

**16. TCC11 recommends that WCPFC12 encourage the Secretariat to continue its work developing the Secretariat's compliance case file system on the IMS, which would allow the Secretariat to track the alleged infringements reported by observers as Article 25(2) matters.**

17. TCC11 was pleased to note that there has been significant progress in the provision operational level catch and effort data by two CCMs. However, there continues to be a significant difference of interpretation as to whether the obligation contained in paragraph 03 (Operational level catch and effort data) of the Scientific Data to be Provided to the Commission is met by providing aggregated catch and effort data and size composition data, as described in paragraphs



04 and 05 of the Scientific Data to be Provided to the Commission.

18. As a result, TCC11 was again unable to assess this obligation. However, TCC11 notes that additional progress in this area is expected in 2016.

19. In conducting its assessment of CMM 2013-01, para 40, TCC11 noted that a majority of CCMs identified one CCM as Priority Non-Compliant against this obligation, while a minority of CCMs believed that the CCM should be assessed as Compliant. The majority view was that despite the fact the CCM had adjusted its annual Bigeye Tuna quota for 2015, to reflect the overage in 2014, the CCM remained Priority Non-Compliant due to the overage. The minority view was that paragraph 40 allows for the adjustment of the following year's quota and thus if the CCM has made that adjustment, it should be assessed as Compliant.

20. Consistent with the 2012, 2013 and 2014 Final Compliance Monitoring Report, CCMs evaluated as "non-compliant" are strongly encouraged to address their implementation issues even without a response procedure.

21. TCC11 agreed not to assess the following paragraphs: CMM 2007-01 paragraph 8, CMM 2007-01, Att K, Annex C, paragraph 4; CMM 2013-01, paragraph 28; Section 03 of the Scientific Data Requirements (as noted above); and Section 07 of the Scientific Data Requirements.

## **V. REQUESTS FOR ASSISTANCE AND CAPACITY BUILDING**

26. Several areas were identified where targeted assistance is required to assist SIDS and other CCMs in implementing specific obligations.
