Dear Mr. Teo,

In accordance with paragraph 13 of Western and Central Pacific Fisheries Commission (WCPFC) Conservation and Management Measure (CMM) 2006-08 – High Seas Boarding and Inspection Procedures (HSB&I), I wish to notify the Commission of the replacement of Japanese authorized inspection vessel named Hakuryu Maru and the amendment of the contact address of Japanese responsible authority. Details for all of authorized Japanese inspection vessels and the responsible authority are attached. Please note that these inspection vessels are clearly marked and identifiable as being on government service.

In relation to inspectors and other crew members of the Japanese inspection vessels, I would also like to advise that they have received and completed training in carrying out boarding and inspection activities at sea consistent with those set out in CMM 2006-08.
